AGREE:

1. You are granted a non-exclusive licence to use our trademarks in relation to our Approved Scheme(s) in accordance with any guidance that we may provide; provided that such use is limited to the relevant trade sectors you have been assessed for and which are subject to this Agreement. Your right to use our trademarks will continue until this Agreement is terminated in accordance with section 4 below.
2. You must comply with any guidance provided by NAPIT and in particular the Codes of Practice, Brand Identity Guidelines, and if applicable, the TrustMark Brand Identity Guidelines. You must at all times preserve the reputation and integrity of the NAPIT Scheme(s) and if applicable, the TrustMark Scheme. You must not engage in any activity or practice which may result in public criticism of us or our Approved Scheme(s) or if applicable, the TrustMark Scheme.
3. In consideration of this licence, you must use best endeavours to promote awareness of NAPIT and if applicable, the TrustMark Scheme to consumers and the trade.
4. This Agreement may be terminated by immediate written notice to you if:
 - a. you cease to participate in our Approved Scheme(s), by failing to renew your annual membership with NAPIT or your membership is either suspended or revoked;
 - b. you go into liquidation or an administrative receiver or receiver and manager or administrator is appointed for you or your assets or you enter into a voluntary arrangement with your creditors or suffer any similar insolvency process or process which affords you protection from your creditors;
 - c. you commit a breach of this Agreement and, following our disciplinary processes, we conclude that this licence should be withdrawn;
 - d. you challenge the validity of our trademarks.
5. Your Membership and TrustMark fees are for a full 12 month period regardless of your trading status.
6. Termination of this Agreement will not affect any existing rights and/or claims that we may have against you, and will not relieve you from fulfilling your obligations which accrued prior to termination.
7. If for whatever reason this Agreement terminates, to protect the reputation of NAPIT and if applicable, TrustMark Scheme and ensure its continued operation:
 - a. you must immediately cease use of our trademarks;

YOUR DECLARATION

On behalf of the above business, I certify to the best of my knowledge all the information I have given in this form is correct. I understand that any inaccurate statement or omissions may disqualify me from registration with NAPIT.

I confirm that I/we possess appropriate public liability insurance of at least £2 million. I can confirm that I possess professional indemnity of at least £250,000 (*only required if you carry out any third party inspections*). I can provide evidence of training and or experience for all operatives carrying out installation work. I confirm that I/my operative(s) have access to relevant technical reference documents. I confirm that I/my operative(s) have access to the calibrated/certificated test equipment (*where required*). I confirm that we have an auditable system which covers appropriate certification and reporting of the work undertaken by the business. I confirm that we have an auditable system identifying responsibilities within the business for the safety, quality and standards of the work. I confirm that we have a written Health & Safety Policy statement where required by law (*for businesses with 5 or more employees*) and will carry out risk assessment as appropriate. I confirm, that by joining one or more of NAPIT's Competent Person Schemes, to NAPIT informing Building Control of the work I/we notify to NAPIT.

I agree to the publication of my/our details being posted on the appropriate websites.

I have read and agree to comply with the NAPIT Code of Practice and to ensure that all operatives employed or sub-contracted by the company are competent for the work they undertake and understand that Membership fees are non-refundable.

Membership fee covers up to 10 operatives. Initial application fee covers on site assessment for 2 operatives if carried out on the same day. Additional assessments are charged at £60.00 (including VAT) per operative if carried out on the same day, up to a maximum of 4 in any one day. If you have more than 10 operatives please call for a quote on 0845 543 0330.

Note 2

Additional Schemes are free to members provided that approval can be granted on the basis of a single assessment visit. Additional Assessment visits, if required, are charged at £240.00 (including VAT) per half day or £408.00 (including VAT) for a full day.

Note 3

TrustMark is optional. NAPIT reserve the right to alter this fee should TrustMark increase their charges to NAPIT.

Note 4

PAT only members are not inspected annually. When assessments are required these will be charged at the PAT assessment fee of £168.00 (including VAT).

Note 5

Up to 8 notifications are included in your Just 8 Membership. If more than 8 notifications are processed you will require upgrading to Full Membership. Please note that TrustMark is not available through Just 8 membership. (See separate Terms & Conditions for Just 8 Membership.)

Note 6

Minimum requirement for Approved Inspector
(1) At least FOUR years post training experience as a fully qualified Electrician.
(2) NVQ level 3 or equivalent in Electrical Installation (eg C&G 236 Pt2).
(3) Qualification on BS7671 (17th Edition).
(4) Qualification on Inspection and Testing (gained within the last five years).
(5) Covered by £250k worth of Professional Indemnity Insurance.

Each year's membership will be regarded as a separate contract and renewal will not be automatic. Failure to pay fees when they are due may result in cancellation of the membership and removal from the register of competent persons; if applicable this would result in requiring a first stage application being submitted for consideration for re-admission to the association.
