CPS	Competent Person Schemes (CPS) allowing self-certification against the Building Regulations in England and Wales.	
EEM	Energy Efficiency Measures (EEM) via PAS2030 certification for installing energy efficiency measures including funding initiatives such as Energy Company Obligation (ECO). To carry out work under ECO, you will also need to be TrustMark registered.	
GDI	Green Deal Installer (GDI) , in addition to EEM certification an assessment against the Green Deal Code of Practice allows listing as a green deal participant for carrying out installation work funded with Green Deal finance.	
TM	TrustMark is a scheme to help consumers identify a reputable tradesperson. NAPIT Scheme Members doing domestic work are eligible to be listed where relevant as "Builders", "Glaziers" or "Roofers" on the TrustMark site.	

ASSESSMENT

For building fabric work, assessments will be arranged based on the scopes applied for below. Assessment includes competence and installation work against the Minimum Technical Competence document. Where the scope includes EEM work, assessments will be against the standard PAS2030.

Column A is used to identify how many site assessments are needed and column B to determine the detailed scope of certification. It is assumed that all the items in column B will be available to assess competence on the visit (generally the most complex system will be seen).

If the visit requires more than one site only those within a 30 minute journey will be valid without further charges.
